Arrangement for conduct of election.

The United Firefighters' Union of Australia, Aviation Branch lodges the following information under subsection 189 (1) of the Fair Work (Registered Organisations) Act 2009:

a) The name of each office in respect of which an election is required:

Branch Organisers – one (1) elected by and from the members employed in each of the following Rescue and Firefighting Units [as named in Rule 56 (2)] who are financial at the time of the close of the roll of voters shall be entitled to vote in the election of the organiser for the said Rescue and Firefighting Unit provided in Subrule 4 of this Rule [rule 70 (3) (b) (iii)].

Branch Organiser – Sydney Rescue and Firefighting Unit

- b) The reason for the election is that this office was not filled at the last election.
- c) The opening date of nominations and closing date of nominations is to be determined by the Returning Officer.
- d) The date on which the roll of voters is to be closed is 7 days before the day on which nominations are opened in relation to elections by a direct voting system for the above listed offices in the union [rule 27].
- e) The kind of voting system to be used in the conduct of the election is a direct voting system.
