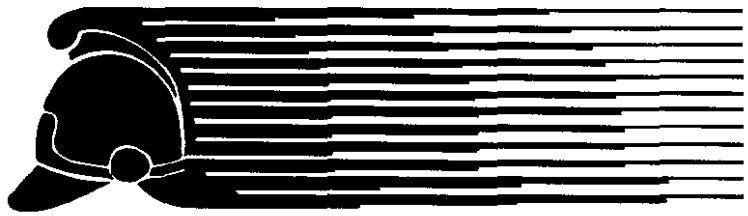

You are made aware that in our Western Australian Branch, insufficient nominations were received to the position of Ordinary Committee Member (Officer).

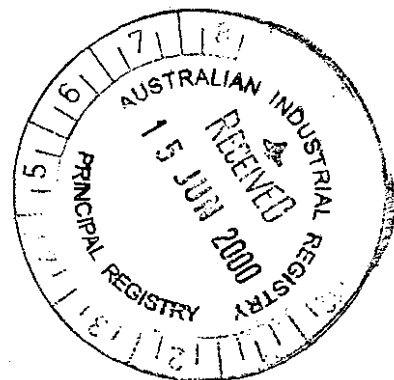
As such, we are requesting that nominations to this position as detailed in the prescribed information again be called, and if necessary, a ballot be conducted.

PART 1: BRANCH OFFICES

- 1 An election is required for the following office:
 - 1.1 In the West Australian Branch, pursuant to West Australian Branch **RULE 3**:
One (1) Ordinary Committee member (Officer)
2. The election is required for the reason that during the election process (E No. 3031 of 2000 referred) insufficient nominations were received for the above position and a single vacancy exists on the Western Australian Branch Committee of Management in the WAFB Officer Ordinary Committee Members component of that Committee..
3. The voting system to be employed in elections for Branch Offices is a direct voting system.

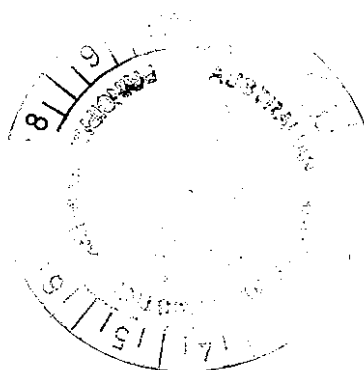


