**Notification of change of offices in the organisation**

Louise Tarrant, National Secretary, wrote to you on 27 March to inform you of the resignation of Troy Burton as National Assistant Secretary, effective 21 March 2014. In that letter Louise indicated that the union would be consulting with and balloting members of United Voice National Council regarding the vacancy created by Troy Burton's resignation.

Rule 20(h)(ii)B of the United Voices Rules states that:

*"B. where a casual vacancy arises in the office of National Assistant Secretary, the National Council may, prior to filling the vacancy pursuant to these rules, resolve whether the office will be abolished or whether it is to be filled on an honorary or full-time basis."*

In accordance with this Rule, the union balloted members of National Council with the following resolution:

Office of National Assistant Secretary  
Moved: Sharron Caddie/Carolyn Smith

1. National Council resolves, in accordance with part 20(h)(ii)(B) of the rules, to abolish the vacant National Assistant Secretary office for the remainder of the current term so that there is one (1) National Assistant Secretary for the remainder of the current term.
2. National Council resolves, in accordance with part 20(h)(i) of the rules, that an office of National Assistant Secretary be abolished for the next quadrennial term so that the number of National Assistant Secretaries to be elected at the 2014 quadrennial elections will be one (1).

I can confirm that the postal ballot of National Council members was successful and subsequently that under the Rules of United Voice the following changes have occurred to

offices in the organisation:

1. The office of National Assistant Secretary has been abolished for the remainder of the current quadrennial term so that there is one (1) National Assistant Secretary for the remainder of the current term.
2. The office of National Assistant Secretary be abolished for the next quadrennial term so that the number of National Assistant Secretaries to be elected at the 2014 quadrennial elections will be one (1).

If you could please update your records to note the above.

**Re: Vacant position of National Assistant Secretary**

I am writing to inform you of the resignation of Troy Burton as National Assistant Secretary, effective 21 March 2014. I note that registered organisations are obliged to inform the Fair Work Commission under s.233(2) of the *Fair Work (Registered Organisations) Act*.

In addition, I would like to inform you of the steps that the union is taking to fill the vacancy created by Troy's departure.

The Fair Work Commission would be aware that 2014 is an election year for United Voice. The Australian Electoral Commission is currently proceeding with elections for Branch-based positions of United Voice, including for National Councillors. Once the Branch-based elections are completed, nominations will open for positions of the National Executive, with a ballot being conducted at the United Voice National Council meeting on or before 3 September 2014.

Due to the timing of the National Assistant Secretary resignation, any ballot to fill the casual vacancy will be conducted shortly before the quadrennial ballot for all of the National Officer positions of United Voice. This timing is being considered by the National Council in conjunction with the appropriate rules of the union as outlined below.

Rule 20(h)(ii)B of the United Voices Rules states that:

*"B. where a casual vacancy arises in the office of National Assistant Secretary, the National Council may, prior to filling the vacancy pursuant to these rules, resolve whether the office will be abolished or whether it is to be filled on an honorary or full-time basis."*

In accordance with this Rule, the union is currently consulting members of the National Council. It is the intention of the union to ballot members of the National Council forthwith relating to this issue. Once a ballot of National Councillors is completed, I will write to you again to inform you of the action that we intend to take.


