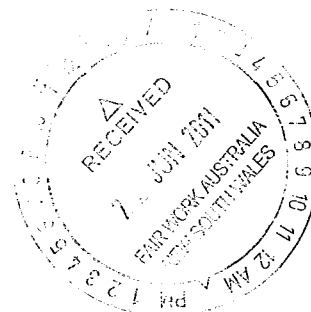

Re: Notice of prescribed information for election

I write to request that an election be held in the NSW Branch of United Voice.

The prescribed information pursuant to s.189(1) of the *Fair Work (Registered Organisations) Act 2009* ("the Act") and Regulation 138 of the *Fair Work (Registered Organisations) Regulations 2009* is as follows:

1. The name of each office or position for which an election is required is:
 - 1.1. New South Wales Branch, Liquor and Hospitality Division, Branch Executive Member (1)
 - 1.2. New South Wales Branch, Liquor and Hospitality Division, Divisional Committee Member (1)
 - 1.3. New South Wales Branch, Community and Property Services Division, Delegate to National Council (1)
2. The reason for the election is:
 - 2.1. In the case of the position described in paragraphs 1.1 and 1.2 above - that a casual vacancy in the office or position has occurred.
 - 2.2. In the case of the position described in paragraph 1.3 above – the office or position was not filled at the previous election.
3. The offices and positions do not have the same name.


4. The electorates for the office or position are as follows:
 - 4.1. In the case of the position described in paragraphs 1.1 and 1.2 above, members of the New South Wales Branch, Liquor and Hospitality Division.
 - 4.2. In the case of the position described in paragraph 1.3 above, members of the New South Wales Branch, Community and Property Services Division.
5. The date and time of the beginning and end of the period in which nominations of candidates will be called for or may be made under the rules of United Voice in relation to the election are contained in rules 40 and 41 of the Rules. It is proposed that, subject to the agreement of Fair Work Australia and the returning officer appointed by the AEC, that nominations be called on 5 August 2011 and close on 26 August 2011.
6. The day on which the roll of voters is to be closed is provided for in Rule 14(b)(iii) of the United Voice rules. It is proposed that, subject to the agreement of Fair Work Australia and the returning officer appointed by the AEC, that the roll of voters closes on 29 July 2011.
7. The voting system to be employed in the conduct of the election is a direct voting system.

I confirm that I am authorised by United Voice and by the rules of United Voice to make this statement on behalf of United Voice and that this information is lodged under subsection 189(1) of the Act.

In the event that nominations close on 26 August 2011, the prescribed information will have been lodged more than two months before the first day when a person may, under the rules of United Voice, become a candidate in an election.
