

I acknowledge receipt of prescribed information dated 30 September 2011, which was lodged with Fair Work Australia on 5 October 2011 for the conduct of an election for United Voice, Queensland Branch.

Paragraph 2 of the prescribed information indicates that a casual vacancy election is required for the offices of Branch Assistant Secretary; Branch Executive Members (3); Delegates to National Council (5) and Delegates to Branch Council (6).

Before a decision concerning an election can be made, Fair Work Australia requires a copy of resignation letters of the former officers or some other form of documentary evidence confirming the reason that the person no longer holds their elected office with United Voice.

Re: Notice of prescribed information for election

I write to request that an election be held in the Queensland Branch of United Voice.

The prescribed information pursuant to s.189(1) of the Fair Work (Registered Organisations) Act 2009 ("the Act") and Regulation 138 of the Fair Work (Registered Organisations) Regulations 2009 is as follows:

- 1. The name of each office or position for which an election is required is:
 - 1.1. Queensland Branch, Branch Assistant Secretary (1)
 - 1.2. Queensland Branch, Branch Executive Member (3)
 - 1.3. Queensland Branch, Delegate to National Council (5)
 - 1.4. Queensland Branch, Delegate to Branch Council (6)
- 2. The reason for the election is that a casual vacancy in the office or position has occurred.
- 3. The offices and positions do not have the same name.
- 4. The electorates for the office or position are the members of the Queensland Branch of United Voice.

- 5. The date and time of the beginning and end of the period in which nominations of candidates will be called for or may be made under the rules of United Voice in relation to the election are contained in rules 40 and 41 of the Rules. It is proposed that, subject to the agreement of Fair Work Australia and the returning officer appointed by the AEC, that nominations be called on 21 November 2011 and close on 12 December 2011.
- 6. The day on which the roll of voters is to be closed is provided for in Rule 14(b)(iii) of the United Voice rules. It is proposed that, subject to the agreement of Fair Work Australia and the returning officer appointed by the AEC, that the roll of voters closes on 18 November 2011.
- 7. The voting system to be employed in the conduct of the election is a direct voting system.

I confirm that I am authorised by United Voice and by the rules of United Voice to make this statement on behalf of United Voice and that this information is lodged under subsection 189(1) of the Act.

In the event that nominations close on 12 December 2011, the prescribed information will have been lodged more than two months before the first day when a person may, under the rules of United Voice, become a candidate in an election.
