CHERITON STREET BUILDING:

Probuild has kept on track for a late August finish. Once winter arrives we may lose a couple of days due to bad weather. The concrete pouring for all floors has been done. We are on track and on budget which is good news.

CASUAL VACANCIES:

The Acting Secretary gave an overview of the process required by the rules of the Union for filling casual vacancies. The Acting Secretary advised of all the steps that have been taken by the Branch to adhere to this process.

Two casual vacancies exist due to the retirement and resignation of Irene Snow, Vice President and the resignation of Dave Kelly, Branch Secretary who won the seat of Bassendean at the March 9 State Election.

Notice of prescribed information for election

I write to request that an election be held for the National Executive of United Voice.

The roll of voters has already closed as it consists of the delegates to the National Council of United Voice elected at the last quadrennial election as well as those subsequent casual vacancies filled either by Branch election or Branch Council appointment.
- 7. The voting system to be employed in the conduct of the election is a direct voting system.

I confirm that I am authorised by United Voice and by the rules of United Voice to make this statement on behalf of United Voice and that this information is lodged under subsection 189(1) of the Act.

In the event that nominations close on 14 June 2013, the prescribed information will not have been lodged more than two months before the first day when a person may, under the rules of United Voice, become a candidate in an election. Accordingly, I request that the General Manager allows the lodged on a later day in accordance with s.189(2).
