I refer to the prescribed information dated 7 July 2014 which was lodged with the Fair Work Commission on 10 July 2014 in relation to the conduct of a scheduled election for offices of the National Executive of United Voice.

Section 189(2) of the Fair Work (Registered Organisations) Act 2009 states that prescribed information must be lodged before the prescribed day, which under regulation 138(3) of the regulations is two months before the first day when a person may become a candidate. It appears that the prescribed day is 26 June 2014, which is before the lodgement of the prescribed information. Re: Application pursuant to Section 182 of the Fair Work (Registered Organisations) Act 2009

I write to request that an election be conducted by the AEC for members of the National Executive of United Voice pursuant to Section 182 of the Fair Work (Registered Organisations) Act 2009 ("the Act").

The prescribed information required under Regulation 138 for the purposes of Section 189(1) of the Act is as follows:

- The names of the offices in respect of which an election is required are (from Rule 20(c) of the rules of United Voice):
 - (i) a National President;
 - (ii) two (2) National Vice Presidents;
 - (iii) a National Secretary;
 - (iv) an Assistant National Secretary;
 - (v) Members from each of the following branches:

New South Wales - two (2)
Queensland - two (2)
South Australia - two (2)
Victoria - two (2)
Western Australia - two (2)
Australian Capital Territory - one (1)
Northern Territory - one (1)
Tasmania - one (1)

- The reason for the election is that the terms of the offices have expired or are due to expire in the normal course of events.
- 3. The numbers of the offices in respect of which an election is required are set out in paragraph 1 above.
- 4. The electorate for the position is the membership of the National Council of United Voice.

- The date and time of the commencement and expiration of the period during which nomination of candidates will be called are dealt with in Rule 22. Nomination must be called for at least seven days prior to the meeting of the National Council on 3 September 2014.
- 6. The voting system to be employed in the conduct of the election is a direct voting system.

The rules provide that this election take place at the National Council meeting to be held on 3 September 2014. Copies of Rules 20, 21 and 22 of the LHMU are attached for your information.

I confirm that I am authorised to sign a statement that this information is lodged under subsection 189(1) of the Act.

I advise that, although Rule 20 (c)(iv) of the union's rules provides for 2 Assistant National Secretaries, Rule 20(h)(i) provides:

- (h) Despite the provisions of Rule 20(c)(iv) the:
 - (i) National Council may, not less than 3 months prior to the opening of nominations for the quadrennial elections of the National Executive, determine the number of National Assistant Secretaries (if any) to be elected provided that if no determination is made then the provisions of rule 20(c)(iv) will continue to apply;

On 8 April 2014, pursuant to her powers under rule 19(i), the National Secretary submitted (inter alia) the following question to a postal vote of all members of National Council:

2. National Cauncil resalves, in accordance with part 20(h)(i) of the rules, that an office of National Assistant Secretary be abolished for the next quadrennial term so that the number of National Assistant Secretories to be elected at the 2014 quadrennial elections will be one (1).

The instructions in the ballot were for ballot papers to be returned to National Office no later than 29 April 2014. 60 votes were received by the cut-off. Of these votes, 25 were classified as informal. Of the 35 votes cast formally, all were in favour of the motion referred to above. Each of the 25 informal votes was also in favour of the motion, 5 votes were received after the cut-off, all in favour of the motion. The motion was declared carried. Accordingly, I request that nominations be called for one Assistant National Secretary only for the 2014quadrennial elections.
