#### Notice of Prescribed information for election

I write to request that an election be held for three vacant offices in the New South Wales Branch of United Voice.

  - In the case of the office of Branch Executive Member representing Liquor and Hospitality Division – all financial members attached to the Liquor and Hospitality Division of the New South Wales Branch;
  - 4.3 In the case of the office of Divisional Executive Member representing Liquor and Hospitality Division - all financial members attached to the Liquor and Hospitality Division of the New South Wales Branch.

5. The date and time of the beginning and end of the period in which nominations of candidates will be called for or may be made under the Rules of United Voice in relation to the election are contained in Rule 42.

- 5.1 The vacancies referred to in paragraphs 1 and 2 above are for terms of office that exceed 12 months and thus do not fall within rule 42(e) of the Rules. Accordingly, Rule 42(d) applies.
- 5.2 This Rule provides:
  - (d) Casual vacancies other than those provided for in sub-rule (e) must be filled by the appropriate manner of election elsewhere provided in these rules.
- 5.3 Rule 40 sets out the "appropriate manner of election.

6. The day on which the roll of voters is to be closed is provided for in Rule 40 of the Union's Rules.

7. The voting system to be employed in the conduct of the election is prescribed in Rule 40(r), which provides:

(r) All elections conducted under this rule will be conducted according to a "first past the post" system of voting such that in any election a person must mark his or her vote on the ballot paper by writing a cross (X) or by making any other legible mark which makes the voter's intention clear in the square opposite the name of the candidate or candidates for whom the person votes.
