#### **Notice of Prescribed Information for Election**

I write to request that an election be held for one vacant office in the A.C.T. Branch of United Voice.

The prescribed information pursuant to S189(1) of the Fair Work (Registered Organisations) Act 2009 and Regulation 138 of the Fair Work (Registered Organisations) Regulations 2009 is set out below.

- a) The name of each office for which an election is required: Nathaniel Guicci – Branch Council
- b) The reason for the election is that casual vacancies in the office referred to above has occurred, as follows:

Office declared vacant pursuant to Rule 64(a)(iv) – absent three consecutive meetings no apology provided

- c) If more than one of the offices or positions for which an election is required has the same name, and the number of offices or positions can, under the rules of the relevant organisation or branch, be determined before the prescribed day – the number of those offices or positions. Six
- d) The electorate for the office or position is as follows: Hospitality
- e) The date and time of the beginning and end of the period in which the nominations of candidates will be called for or may be made under the Rules of United Voice in relation to the election are contained in Rule 42.
  - e.1. The vacancy referred to in Paragraphs 1 and 2 above is for a term of office that exceeds twelve (12) months and therefore does not fall within Rule 42(e) of the Rules.
  - e.2. This Rule provides:
    - e.2.1.Casual vacancies, other than those provided for in sub-rule (e), must be filled by the appropriate manner of election elsewhere provided in these rules.
  - e.3. Rule 40 sets out the "appropriate manner of election".

- f) The day on which the roll of voters is to be closed is provided for in Rule 40 of the Union Rules.
- g) The voting system to be employed in the conduct of the election is prescribed in Rule 40(r), which provides:
  - g.1. All elections conducted under this Rule will be conducted according to o "first past the post" system of voting such thot in any election o person must mark his or her vote on the ballot poper by writing a cross (X) ar by making ony other legible mark which makes the voter's intention clear in the square opposite the nome of the candidate or candidates for whom the person votes.

I advise at the meeting of our Branch Executive meeting held on 2<sup>nd</sup> March this year I provided a report in relation to resignations from Branch Executive and Council positions.

In response to my report the following resolution was carried unanimously,

"This Executive notes and accepts the signed resignation of Linda Morrison (copy attached) from her position on Branch Executive.

The Executive notes and accepts the signed resignation of Charlie Brincat (copy attached) from his position on Branch Council."

Rule 64(a)(iv) provides that if a member is absent from three consecutive meetings without a satisfactory apology, the Branch President must declare the office vacant when advised by the Branch Secretary. The Branch President noted that Maddie Griffin, Elba Cruz, Nathaniel Guicci and Daniel Finlay have not attended the last three meetings and declared the offices vacant at the Branch Executive meeting 2<sup>nd</sup> March.

Maddie Griffin has subsequently notified me by text message that as she has moved overseas and will not be returning until 2016 she wishes to resign her position. Phone contact has also been made with Elba Cruz and Daniel Finlay, both of whom have verbally expressed their wishes to resign from their respective offices.

I note that Nathaniel Guicci was not included on the original Prescribed Information and request for election however we will submit a separate request through the National Secretary as soon as possible to enable this position to be included.
