Reminder of actions required when persons elected to office

The Australian Electoral Commission has provided the Commission a declaration of results for the election [E2015/192]. This letter is a reminder of certain obligations imposed on organisations and persons elected to office.

Section 154D(1) of the *Fair Work (Registered Organisations) Act 2009* (the RO Act) requires the rules of organisations (and branches of organisations) to require each officer with financial management duties to undertake approved training that covers those duties within 6 months after the person begins to hold office. Please ensure that relevant officers undertake approved training within the required timeframe.

Please also ensure that all new holders of office are advised of their obligations to make disclosures regarding remuneration, non-cash benefits and material personal interests, the details of which should be provided for in your organisation's rules.

Also, section 233(2) of the RO Act requires that an organisation must notify the Fair Work Commission (the Commission) within 35 days of any changes to the holders of office in the organisation. If the election has resulted in any changes to the holders of office, the United Voice must notify the Commission of these changes. In particular, please advise:

- Person(s) who have ceased to hold office:
 - the name of the office vacated;
 - the date of the change of office holder; and
 - the name of the person vacating the office.
- 2. Person(s) who have commenced to hold office:
 - the name of the office now held;
 - the date of the change of office holder;
 - the name of the person now holding the office;
 - the postal address of the person (generally the postal address of the organisation); and
 - the occupation of the person now holding the office.

The notification must include a declaration by the Secretary (or other prescribed officer) that the information is a correct statement of the changes made. I have attached a template notification of changes which may assist you. If any change does not apply until a specific date, you don't need to notify until then (e.g. AGM, 1 January, 2nd Monday in March). If you have already lodged this information, please disregard this reminder.

Notice of Prescribed Information and Request for Election

I write to request that an election be held for one vacant office in the Northern Territory Branch of United Voice and for one vacant NT Branch delegate position for National Council.

The prescribed information pursuant to S189(1) of the Fair Work (Registered Organisations) Act 2009 and Regulation 138 of the Fair Work (Registered Organisations) Regulations 2009 advising Fair Work of Matthew Gardiner's resignation as NT Branch Secretary, was provided on 10th February 2015. Following a process, as previously advised, of undertaking a review of the NT Branch structure, the National Executive at its meeting on 11th/12th June 2015 resolved to proceed to request an election for the office of NT Branch Secretary.

 - 5.1. The vacancy referred to in Paragraphs 1 and 2 above is for a term of office that exceeds twelve (12) months and therefore does not fall within Rule 42(e) of the Rules.

- 5.2. This Rule provides:
 - 5.2.1.Casual vacancies, other than those provided far in sub-rule (e), must be filled by the apprapriate manner of election elsewhere provided in these rules.
- 5.3. Rule 40 sets out the "appropriate manner of election".
- 6. The day on which the roll of voters is to be closed is provided for in Rule 40 of the Union Rules.
- 7. The voting system to be employed in the conduct of the election is prescribed in Rule 40(r), which provides:
 - 7.1. All elections conducted under this Rule will be conducted occording to a "first post the post" system of voting such that in any election a person must mark his or her vote on the ballot paper by writing a cross (X) or by making ony ather legible mark which makes the vater's intention clear in the square opposite the name of the candidate or candidates for whom the person votes.
