### Reminder of actions required when persons elected to office

The Australian Electoral Commission has provided the Commission a declaration of results for the election [E2015/199]. This letter is a reminder of certain obligations imposed on organisations and persons elected to office.

Section 154D(1) of the *Fair Work (Registered Organisations) Act 2009* (the RO Act) requires the rules of organisations (and branches of organisations) to require each officer with financial management duties to undertake approved training that covers those duties within 6 months after the person begins to hold office. Please ensure that relevant officers undertake approved training within the required timeframe.

Please also ensure that all new holders of office are advised of their obligations to make disclosures regarding remuneration, non-cash benefits and material personal interests, the details of which should be provided for in your organisation's rules.

Also, section 233(2) of the RO Act requires that an organisation must notify the Fair Work Commission (the Commission) within 35 days of any changes to the holders of office in the organisation. If the election has resulted in any changes to the holders of office, the United Voice must notify the Commission of these changes. In particular, please advise:

- 1. Person(s) who have ceased to hold office:
  - the name of the office vacated;
  - the date of the change of office holder; and
  - the name of the person vacating the office.
- 2. Person(s) who have commenced to hold office:
  - the name of the office now held;
  - the date of the change of office holder;
  - the name of the person now holding the office;
  - the postal address of the person (generally the postal address of the organisation); and
  - the occupation of the person now holding the office.

The notification must include a declaration by the Secretary (or other prescribed officer) that the information is a correct statement of the changes made. I have attached a template notification of changes which may assist you. If any change does not apply until a specific date, you don't need to notify until then (e.g. AGM, 1 January, 2nd Monday in March). If you have already lodged this information, please disregard this reminder.

Arrangement for conduct of election.

[1] On 3 July 2015, United Voice lodged with the Fair Work Commission (the Commission) prescribed information in relation to an election for offices of the Northern Territory Branch (the Branch) of United Voice due to insufficient nominations in a previous election (E2014/64).

#### Notice of Prescribed Information and Request for Election E2015/199

I write to amend the Prescribed Information supplied in my earlier letter of 29 June 2015. The discrepancies as advised by your email 3<sup>rd</sup> August 2015, came about due to a record keeping error at the NT Branch during the transition of staff. This has now been rectified and the accurate information obtained.

Please find attached the amended Prescribed Information for the conduct of the elections for the unfilled NT Branch Council offices from the 2014 quadrennial elections. In obtaining a copy of the declaration of result for E2014/64 it is noted that there are twenty three (23) unfilled positions. I hereby request that an election be held for twenty three (23) vacant offices in the Northern Territory Branch Council of United Voice.

The prescribed information pursuant to S189(1) of the Fair Work (Registered Organisations) Act 2009 and Regulation 138 of the Fair Work (Registered Organisations) Regulations 2009 advising Fair Work is attached.

- 5. The date and time of the beginning and end of the period in which the nominations of candidates will be called for or may be made under the Rules of United Voice in relation to the election are contained in Rule 42.
  - 5.1. The vacancy referred to in Paragraphs 1 and 2 above is for a term of office that exceeds twelve (12) months and therefore does not fall within Rule 42(e) of the Rules.
  - 5.2. This Rule provides:
    - 5.2.1.Casual vacancies, other than those provided for in sub-rule (e), must be filled by the appropriate manner of election elsewhere provided in these rules.
  - 5.3. Rule 40 sets out the "appropriate manner of election".
- 6. The day on which the roll of voters is to be closed is provided for in Rule 40 of the Union Rules.
- 7. The voting system to be employed in the conduct of the election is prescribed in Rule 40(r), which provides:
  - 7.1. All elections conducted under this Rule will be conducted according to a "first past the post" system of voting such that in any election a person must mark his or her vote on the ballot paper by writing a cross (X) or by making any other legible mark which makes the voter's intention clear in the square opposite the name of the candidate or candidates for whom the person votes.

### Arrangements for the conduct of an Election (E2015/199)

I refer to the prescribed information which was lodged with the Fair Work Commission (the Commission) on 3 July 2015 in relation to a casual vacancy election for fifteen (15) Branch Council Delegates in the Northern Territory Branch (the Branch).

As stated in the prescribed information, the vacancies arose due to insufficient nominations in the scheduled quadrennial election (E2014/64). I have analysed the list of Branch Council Delegates from the respective sections as requested in the prescribed information, and compared it with the declaration of results from the Australian Electoral Commission in E2014/64. I have noted the following discrepancies.

### Number of Branch Council Delegates

In the following Sections, the number of Branch Council Delegates requested in the prescribed information is fewer than the number of vacancies shown in the declaration of results for E2014/64:

- In the Aboriginal Health, Hostels and other Organisations (Darwin, Batchelor and surrounding areas) Section there were two vacancies from E2014/64, but the current prescribed information requests only one of them to be filled.
- In the Public Health (Darwin) Section there were three vacancies from E2014/64, but the current prescribed information requests only two of them to be filled.
- In the Security and Immigration Detention Centres Section, there were three vacancies from E2014/64, but the current prescribed information requested only one of them to be filled.
- In the Alice Springs and Tennant Creek General Section, there were two vacancies from E2014/64, but the current prescribed information does not request any Branch Council Delegates from this Section.

If the number of Delegates in the four Sections listed above has been decreased by the Northern Territory Branch Council since the election in E2014/64 in accordance with rule 53(b), could you please provide a copy of a Branch Council resolution endorsing that decision. Alternatively, if the number of members in the four Sections listed above is not correct, could you provide amended prescribed information which requests the correct number of offices to be filled.

### Confirmation of Section title

In E2014/64 there was one vacancy for a Branch Council Delegate from the Gove Section. The

Level 10, Terrace Tower 80 William Street East Sydney NSW 2011 current prescribed information requests one Branch Council Delegate from the *Mining and Processing* – *Gove* Section. Could you confirm if this is the same Section as the one listed in E2014/64, and if so, could you confirm the correct name of the Section.
