The Liquor, Hospitality and Miscellaneous Union ("the LHMU"), being an organisation recognized under Schedule 1 of the *Workplace Relations Act* 1996 ("the Act") makes application under sections 245 and 246 of that Schedule for a change to its reporting units, as follows:

- 1. From 1 July, 2008 the ACT Branch will cease to be a reporting unit for the purposes of section 242 of Schedule 1 of the Act;
- 2. From 1 July, 2008 the National Office of the LHMU will be the reporting unit for the ACT Branch, and reports required to be made from time to time in respect of the financial affairs of the Branch will form part of and be integrated into the National Office report prepared and filed pursuant to section 242 of Schedule 1 of the Act.

The LHMU also makes application under subsection 247(2) of Schedule 1 of the Act for an alteration to its Rules to give effect to the alteration of its reporting units (see paragraph 6, below). The terms of the proposed Rule alteration are set out in the Minutes of a meeting of the ACT Branch Council of the LHMU held in Canberra on 19 March 2008. Specifically, the Minutes set out the text of a proposed new Rule 75A.6 adopted by the ACT Branch Council, The text of this proposed Rule alteration has also been endorsed by the National Executive of the LHMU.

Verification of facts set out in this application

3. A declaration signed by Tim Ferrari, Assistant National Secretary of the LHMU, who is authorized to make the declaration, is attached and marked <u>Annexure A</u>. The declaration verifies the facts set out in this application and in the documents being lodged with the application.

Details of existing reporting units

4. For the purposes of compliance with Part 3 of Chapter 8 of Schedule 1 of the Act, and as permitted by section 245 of Schedule 1 of the Act, the eight Branches of the LHMU and the National Office are existing reporting units. The ACT Branch is one of the eight Branches of the LHMU.

Details of the proposed alternative division into reporting unit

5. The LHMU seeks to divide the organization into reporting units on an alternative basis, namely in the manner set out in paragraphs 1 and 2 above. The other seven Branches of the organisation will continue to be reporting units pursuant to section 242 of Schedule 1 of the Act.

Resolutions in favour

- 6. A copy of the Minutes of a Combined Branch Executive and Branch Council meeting of the ACT Branch, held in Canberra on 19th March 2008, is attached and marked <u>Annexure B</u>. Those minutes record the adoption of a proposed new sub-rule 75A.6 of the registered Rules of the LHMU, in which the proposed alternative reporting unit was specifically articulated.
- 7. The declaration signed by Tim Ferrari (<u>Annexure A</u> hereto) sets out the terms of three resolutions relating to the proposed alternative reporting unit. These resolutions were adopted in a postal ballot by a majority of members of the National Executive of the LHMU. The ballot was declared on 28 April 2008.

Publication of notice of this application

8. The LHMU has a web-site which can be located at:www:lhmu.org.au. The LHMU has posted a notice on the website that it has lodged this application. A copy of the notice is annexed hereto (Annexure C).

Reasons supporting the proposed division

9. The National Office of the LHMU and the ACT Branch have reached an agreement on the more efficient use of Branch resources, freeing up Branch personnel and resources to concentrate on core activities. The agreement provides that the National Office will take full administrative responsibility from 1 July 2008 for financial tasks for the Branch.

- 10. Subject to the Annual Budget approved for the Branch by National Executive, the Branch Secretary will have authority to incur expenditure on behalf of the Union for approved Branch activities. Extraordinary non-Budget expenditure must be approved by the National Secretary. The Branch will forward written advice to National Office of all expenditure.
- 11. All employees of the Branch will continue to report to and remain under the direction of the Branch Secretary.
- 12. National Office will collate all changes in membership for the Branch and will provide a monthly report of membership movements and the financial status of members.

- 13. The Branch will have responsibility for Branch industrial matters.
