As discussed, I refer to the request for a casual vacancy election for a NSW Branch Council Delegate representing the Community and Property Services Division, which was lodged on 17 September 2015.

The prescribed information refers to and attaches a copy of the declaration of results from E2015/110, which shows that there were no nominations for the office in election E2015/110. The election in E2015/110 was a casual vacancy election due to the resignation of Odile Tomin as a Branch Council Delegate.

The attached AEC declaration of results from the quadrennial election, E2014/64, shows that Odile Tomin was a Branch Council Delegate in the Leisure and Tourism Division.
