While the information contained in your statutory declaration appears in order, I should point out that the declaration should have been signed by an officer of the organisation. I appreciate this office has accepted statutory declarations declared by you in the past, however subsections 268(3)(a) and (b) of the Act require the lodgement of a statutory declaration by the Secretary or other prescribed officer. "Office" is defined under section 4 of the Act as an office of a voting member of a collective body of the organisation or branch, being a collective body that has power in relation to certain functions described in section 4.
