Thank you for your letter of 31 March 2003 together with statutory declarations declared on the same day providing information in accordance with subsection 268(3) of the *Workplace Relations Act 1996*.

While the information contained in your statutory declarations appears in order, I should point out that the declarations should have been signed by an officer of the organisation. I appreciate this office has accepted statutory declarations declared by you in the past, however subsections 268(3)(a) and (b) of the Act require the lodgement of a statutory declaration by the Secretary or other prescribed officer. "Office" is defined under section 4 of the Act as an office of a voting member of a collective body of the organisation or branch, being a collective body that has power in relation to certain functions described in section 4. It would appear from the rules that the duties of 'Industrial Officer' are such that would not bring the position into line with the definition of "office" appearing in the Act.

I therefore request a fresh statutory declaration from the organisation declared by an officer of the organisation.




1. That I am the President for the Victorian Automobile Chamber of Commerce.
2. At the meeting called on Wednesday, 29 September 1999, to vote for the proposed change to VACC's Rules, the members assembled discussed at length the implications of the proposed changes.
3. In the course of those discussions, the members attention was drawn to Section 199 of the Workplace Relations Act 1996, in relation to terms of office permitted under the provisions of the Act. The members attention was drawn particularly to Section 199(3) regarding the extension of terms of office for the purpose of synchronising elections.
4. The members assembled discussed the necessity to conduct future elections within VACC in the following order:
 - (i) Divisional Executive Committee
 - (ii) Divisional Chairman and Vice Chairman.
 - (iii) President, Executive Director and Industrial Officer
 - (iv) Board of Management
 - (v) Executive Board, Senior and Junior Vice President
5. The members assembled noted that the current Divisional Elections for office bearers did not fall within the provisions of "office" of the Workplace Relations Act.
6. The members assembled acknowledged that the Divisional term of office was currently twelve months as was the term for the Executive Director and Industrial Officer.
7. The members assembled agreed that the Divisional office bearers, Executive Director and Industrial Officer should remain in office until the election period during the Year 2000.


