Recently, the Association filed pursuant to Section 214 of the Workplace Relations Act, prescribed information for an election to be conducted for the Association's Board of Management

Subsequent to that, we have been advised that a Division, the Commercial Vehicle Body Manufacturers Association (CVBMA), which has not met for some time, but which has been a Division since 1983, wishes to put forward a nomination for a position on the Board of Management. The Division has already held its AGM and has elected an Executive Committee and Chairman. The Chairman of the Division, Mr Neil Smith, has lodged a nomination form for a position on the Association's Board of Management with the AEC.

In the original notice filed with the Registry, no reference to CVBMA was made, due to the fact that we were unaware that the Division was in the process of reactivating and intended to seek a position on the Board of Management.

#### G. Update Report on Pre-Purchase Inspection Service

Mr Purchase provided an update on the Pre-Purchase Inspection Service and reported that requests for inspection had increased even though the advertising and promotional budget had been modest. The best results had been achieved through advertising in the Trading Post newspaper.

#### H. Amalgamation with TACC

Mr Redfern reported that TACC had officially been deregistered as an industrially registered organisation on 1 March and the amalgamation with VACC was complete.

All TACC and VACC members had been advised and a function to formally convey to TACC members that their organisation had amalgamated with VACC was to be held in Hobart on 30 March.

Mr Howes asked how TACC would be represented on the VACC Board of Management. Mr Purchase explained that the TACC Board would become a Committee and then nominate a representative to the VACC Board of Management. When that had been done, VACC would advise the Industrial Registrar. The Board of Management discussed TACC representation and unanimously resolved that:
