1. WELCOME

The President welcomed Mr. Tony Sanchez, attending as an observer for the Automotive Electrical Division and acting as AED Chairman following the resignation of Mr. Les Richardson from the Chairmanship and from the Board of Management.

The President asked for a resolution on the brand advertising campaign. It was moved by Mr. Kirwan and seconded by Mr. Rickard :

"THAT THE BOARD OF MANAGEMENT CONFIRMED THE DIRECTION IN WHICH VACC WAS HEADING WITH THE BRAND MARKETING CAMPAIGN."

The Board of Management noted the Report.

B. MEMBER DISCOUNTS

The Senior Manager, Marketing, Media and Publications, Mr. O'Brien, referred to the meeting papers and highlighted the discounts available to VACC members. He highlighted the Commonwealth Bank EFTPOS deal, which VACC had negotiated at a very competitive 0.86% charge for transactions. He also referred members to the VACC Website, which included a calculator of savings on EFTPOS using the Commonwealth Bank discount arrangement.

He also reported on a new member discount proposed for a financial services package through Members Equity. He said the Members Equity organisation was established with the support of Australia's industry superannuation funds, including the MTAA Super Fund. A Heads of Agreement had been signed by VACC and Members Equity.

Members Equity was about to commence intensive brand marketing, which would assist VACC to publicise the new arrangement to members.

Mr. O'Brien said a new telephone deal was also close to being announced. However, the electricity deal with AGL was taking much longer and becoming difficult.

The Board of Management noted the Report.

C. ESTABLISHMENT OF A DISMANTLERS AND PARTS RECYCLERS DIVISION

The President asked the General Manager, Divisions and Membership, to report. Mr. Jurkschat said there was a growing number of retail automotive businesses eligible for such a Division. VACC had planned to create an opportunity for existing members and new members in the recycling industry to be formally represented by the VACC.

He referred to the meeting papers, which included draft application forms and draft rules and by-laws for a new VACC Division. He said there were approximately 250 businesses eligible to join the proposed Division and there was support for the formation of the Division amongst industry participants. The President asked for questions or comments on the proposal.

Mr. Buskes asked whether motorcycle recyclers would be eligible to join. Mr. Jurkschat answered, "Yes" and they would be most welcome.

There was discussion about the name of the Division, and it was moved by Mr. Blake and seconded by Mr. Owen Brown:

"THAT THE WORD "PARTS" BE DELETED FROM THE NAME OF THE PROPOSED DIVISION."

The motion was carried.

The President asked for further discussion. Mr. Howes commented that he supported the establishment of the Division, but did not agree that recyclers of oil should be included.

Mr. Blake said that an Automotive Dismantlers and Recyclers Division could also create sub-categories to cater for specialists as had been done by the Automobile Repairers Division.

Mr. Warren Smith asked, "Where do vehicle part importers and exporters fit into the VACC member division structure?"

The Executive Director agreed to answer Mr. Warren Smith's question, on notice.

It was moved by Mr. Owen Brown and seconded by Mr. Graeme Hill:

"THAT THE BOARD OF MANAGEMENT AGREES TO THE ESTABLISHMENT OF A NEW VACC DIVISION TO BE KNOWN AS THE AUTOMOTIVE DISMANTLERS AND RECYCLERS DIVISION."

The motion was carried.

D. VEHICLE SAFETY

The Senior Manager, Government and Public Affairs, Mr. Russell, reported on the VACC political campaign to improve vehicle maintenance, inspection and safety. He said there were four components of the current strategy and each was reported in the Board papers. The Five Point Safety Inspection project was the first. It continued to meet with member approval.

Second was the F100 testing to demonstrate how an unroadworthy vehicle was unsafe under emergency braking.

The third element was publicity generated by VACC on the F100 and broadcast by Channel 7 on the Today Tonight programme. The fourth was a Vehicle Safety Forum, hosted by VACC on the subject of "Vehicles as Workplaces".
