**Annual Return of Information for 2016 [AR2016/68]**

I acknowledge receipt on 18 March 2016 of your Declaration providing information in accordance with subsection 233(1) of the *Fair Work (Registered Organisations) Act 2009* (the RO Act).

The documents lodged cover most the required information for the 2016 Annual Return of Information of Victorian Farmers Federation Industrial Association. The documents have been filed and can be viewed on the Fair Work Commission website through the List of Registered Organisations - <http://www.fwc.gov.au/index.cfm?pagename=regorgslist>. However I make the following comments to assist with future lodgements.

As part of the Declaration, we require a list of all offices that are scheduled to be elected during the course of the year. The elections for members of the Executive Committee were not included. I note that the Delegate has already issued a decision for the arrangement for conduct of an election in relation these offices (E2016/68), however it remains a requirement that the information is included in the Declaration.

In order to assist organisations to fully comply with the requirements of subsection 233(1) of the Act a template annual return is available on the [fact-sheets](#) page of our website.

**Notifications of Change**

Any changes to these records must be notified to the Commission within 35 days of the change. A template Notification of Change Declaration is available on the [fact-sheets](#) page of our website. I note that this template was not used last year when filing the Notifications of Change Declaration after the scheduled election in 2015. The Victorian Farmers Federation Industrial Association is encouraged to use this template if any changes occur to ensure all necessary information is provided to the Commission.


