Reminder of actions required when persons elected to office

The Australian Electoral Commission has provided the Registered Organisations Commission (the ROC) a declaration of results for the election of uncontested offices in matter E2019/11. This letter is a reminder of certain obligations imposed on organisations and on persons elected to office.

A notice must be published on the organisation's website

The organisation or branch must, as soon as practicable after receiving the post-election report, publish on its website a notice that a copy of the report is available from the organisation, branch or the AEC on request. The notice must be kept on the website for a period of at least 3 months (see regulation 141 of the Fair Work (Registered Organisations) Regulations 2009).

Holders of office required to undertake approved training

Section 293K of the Fair Work (Registered Organisations) Act 2009 (the RO Act) requires each officer with financial management duties to undertake approved training that covers those duties within 6 months after the person begins to hold office. Please ensure that relevant officers undertake approved training within the required timeframe. Please also ensure that all new holders of office are advised of their obligations to make disclosures regarding remuneration, non-cash benefits and material personal interests, the details of which are provided for in the RO Act.

Organisation must notify the Commission of changes

Also, section 233(2) of the RO Act requires that an organisation must notify the Commission within 35 days of any changes to the holders of office in the organisation. If there are no changes a notification is not required. If the election has resulted in any changes to the holders of office, the Victorian Farmers Federation Industrial Association must notify the Commission of these changes. In particular, please advise:

- 1. Person(s) who have ceased to hold office:
 - the name of the office vacated:
 - the date of the change of office holder; and
 - the name of the person vacating the office.
- 2. Person(s) who have commenced to hold office:
 - the name of the office now held;

 - the postal address of the person (generally the postal address of the organisation); and

the occupation of the person now holding the office.

The notification must include a declaration by the Secretary (or other prescribed officer) that the information is a correct statement of the changes made. A template notification of changes, which may assist you, is attached. If any change does not apply until a date in the future, you do not need to notify until then (e.g. AGM, 1 January, 2nd Monday in March). If you have already lodged this information, please disregard this reminder.

DECISION

Fair Work (Registered Organisations) Act 2009 s.189—Arrangement for conduct of an election

Victorian Farmers Federation Industrial Association (E2019/11)

MELBOURNE, 8 May 2019

Arrangement for conduct of election.

[1] On 22 March 2019 the Victorian Farmers Federation Industrial Association (the **Association**) lodged with the Registered Organisations Commission prescribed information for an election to fill the following offices:

Vice President	(1)
Treasurer	(1)

Late lodgement of Prescribed Information

- [2] The Association did not lodge the prescribed information before the prescribed day as required by regulation 138(3) of the *Fair Work (Registered Organisations) Regulations 2009* (the Regulations).
- [3] In circumstances where the Annual General Meeting (**AGM**) must occur by 31 July of each year as provided in rule 31.1 of rule book dated 19 April 2017 (R2016/308), the prescribed information must be lodged by 18 March. Consequently, the prescribed information was lodged 3 days out of time.
- [4] In its preceding election E2018/36, the Association lodged the prescribed information on 22 March 2018 and this was also lodged outside of the statutory period as prescribed by regulation 138(3) of the Regulations by a period of 3 days. However, it appears that this issue was not brought to the attention of the Association.
- [5] On 17 April 2019, the President of the Association submitted a written request for lodgement of the prescribed information on a later day in accordance with section 189(2) of the Fair Work (Registered Organisations) Act 2009 (the RO Act) for this election E2019/11. The reason for delay was cited as an oversight by the organisation and that the date for the AGM had not been decided at the time which ultimately effected the date on which the prescribed information must be lodged.

- [6] There is a reasonable expectation that registered organisations take steps to ensure that they comply with the time-frame requirements as set out not only in the RO Act but also in instruments such as the organisation's own rules.
- [7] I have considered the consistency in the days of lateness in the Association's lodgement of the prescribed information in this and previous election. I have also considered the reasons for delay provided by the President of the Association.
- [8] It appears that the relevant date for the lodgement of prescribed information has not to this point been clear to the Association which is a matter that has now been remedied. The Association is also aware that section 189(2) of the RO Act is a civil penalty provision.
- [9] In the circumstances, I grant the request for a later date for lodgement and note that any further applications to lodge on a later date are unlikely to be granted on the basis of the same oversight and or erroneous assumptions made in this and previous election cycles.
- [10] I am satisfied that an election for the above-named offices is required to be held under the rules of the organisation and, under subsection 189(3) of the RO Act, I am making arrangements for the conduct of the election by the Australian Electoral Commission.
