On behalf of The Victorian Showmen's Guild, I wish to lodge an application in respect of an **Election of Committee for 2010**.

The Offices positions are as follows: -

The term of office is for one year. The reason for the Election, being in accordance with the Rules of the Guild, to conduct an annual election. The persons are elected on a simple majority basis with members voting directly by mail.
