UNION WA DIVISION ELECTION CERTAIN OFFICES

I am the duly elected Secretary of the Western Australian Shire Councils, Municipal Road Boards, Health Boards, Parks, Cemeteries, Race Course, Public Authorities and Water Boards Union, Western Australian Division (the Union) having been declared elected for a four year term by the Returning Officer appointed by the Australian Electoral Commission on the 8th of October 2013.

As the duly elected Secretary, I hereby make application for the conduct of an election to be conducted for the below listed offices.

It will be noted from the Rules that the existing election process does not provide for an express period for nominations to be lodged or for the closing of the roll. In the request for an election, the Union has nominated time frames that it considers reasonable having regard for the size of the electorate.

2. REASON FOR THE ELECTION

The election will allow the Union to move to an election of officers for the Union Office Bearers pursuant to the advice of FWA and the requirements of Rules 17 and 23 of the Union General Rules and to comply with Rules 25 and 26 of the WESTERN AUSTRALIAN DIVISION RULES to the vacating of the offices of President by resignation, the vacating of the offices of Union Councillor (4) by resignation, the vacating of the offices of Murchison, Goldfields and Coastal Districts Zone Delegate(s) by resignation and the non-filling of the offices of Zone Delegate at the quadrennial elections held in October 2013 for the offices of Central, South Western, Murchison, Pilbara and Kimberley Territories Zone Delegate(s).

3. ELECTORATE

In respect of the offices of President, Union Councillor and Committee Persons, all members of the Western Australian Division of the Union. In respect of the offices of Zone Delegates, all those members attached to that Zone.

4. NOMINATION PERIOD

Nominations for all offices should be opened at the earliest possible practical date approved by the Fair Work Commission and by the Australian Electoral Commission.


5. CUT OFF DATE FOR THE ROLL
