- [2] I note that the organisation has advised the Commission that it will shortly be considering changes to its rules which, if adopted and subsequently certified by the Fair Work Commission, would have the effect of altering the terms of office and the number of officers. The organisation has indicated to Commission staff that it is considering delaying these changes and/or their implementation until after this election is conducted. In the circumstances, I consider that this is a sensible approach in order to avoid the situation of rule alterations impacting an impending election.
- [3] I am satisfied that an election for the abovenamed offices is required to be held under the rules of the organisation and, under subsection 189(3) of the *Fair Work (Registered Organisations) Act 2009*, I am making arrangements for the conduct of the election by the Australian Electoral Commission.
