Your primary review

Your ORP statement had a **primary review** which checked whether it was signed by an officer, lodged on time, included the required NIL statements and whether you met any requirements that the ROC raised with you last year.

Insufficient Nil Statements



The ROC understands that not all organisations and branches have five or more officers who receive relevant remuneration or have made payments to related-parties.

Your ORP statement did not contain a NIL statement in regard to a fifth officer, and this made it unclear whether you had fully completed the statement.

Section 293J of the RO Act does not require an organisation or branch to explicitly state that certain items were 'nil'. However it is the view of the ROC that such statements would provide greater clarity and transparency for members.

Such statements reassure the organisation's members and the ROC that the organisation or branch has turned its attention to the question of officers' relevant remuneration, their non-cash benefits and payments to related parties.

Please ensure that next year's ORP statement contains NIL statements where appropriate.

The ROC's risk-based approach

This year your ORP statement was assessed against a primary review. A primary review does not check all legislative requirements.

Over a five year period the ORP statement of every organisation and branch will be subject to at least one advanced review. An advanced review is a more comprehensive review.
